AdCoin privacy policy

This privacy policy has been compiled to better serve those who are concerned with how their 'Personally Identifiable Information' (PII) is being used online. PII, as described in US privacy law and information security, is information that can be used on its own or with other information to identify, contact, or locate a single person, or to identify an individual in context. Please read our privacy policy carefully to get a clear understanding of how we collect, use, protect or otherwise handle your Personally Identifiable Information in accordance with our website.

Privacy policy changes

What personal information do we collect from the people that visit our blog, website, app or crypto advertising platform?

Website/blog/app:

- When ordering or registering on our site, as appropriate, you may be asked to enter your name, email address or other details. We save this including with your wallet address.
- We save your behaviour on our site.
- When you use our support service we save your previous mails so we can give you a better costumer experience.
- When you use our AdCoin pro account we save your additional personal information.

Crypto advertising platform:

- We save your name, username, email address, wallet address and other personal information that you choose to provide
- We save previous campaigns and transactions.
- We save information about the advertisers and publishers.

We don't save information that doesn't have anything to do with AdCoin such as ip address/advice etc. by our own. But we do use cookies.

When do we collect information?

We collect information:

- When you register on our site,
- When you place an order

- When you enter information on our site.
- When you use our support service
- When you use our crypto advertising platform.

The information that we collect is collected automatically. But if you use our services we let you know that we save your personal information by selected an option before we are going to save your information. You are free to refuse but then it's not possible to use our services. Of course you can buy and use AdCoin through another way.

How long do we save your information?

AdCoin click b.v. saves your information during the time that you use our services but there is an exception:

- The information that you provide for the AdCoin pro account is saved for a maximum of 5 years.

How can you delete your personal information?

Of course it is possible to delete your personal information. If you want so please send a mail to support@getadcoin.com

Personal information that you can delete and still use our services:

- AdCoin pro account information
- Support emails (but further use with limited options)
- Additional personal information
- Previous campaigns.

It's not possible to delete other information and still using our servicing because of the legal restrictions in the Netherlands and the KYC policy.

You have in anytime the rights to see, to adjust or to remove your personal information.

Why do we use your personal information?

We have to save personal information such as name, email address etc. to satisfied the law in our Home country (The Netherlands). We have also had the deal with the KYC policy to avoid that our services are going to be used for criminal activities.

We may use the information that we collect from you when you register, make a purchase, sign up for our newsletter, respond to a survey or marketing communication, surf the website, or use certain other site features in the following ways:

- To personalize your experience and to allow us to deliver the type of content and product offerings in which you are most interested.
- To administer a contest, promotion, survey or other site feature.

How do we protect your information?

We do not use vulnerability scanning and/or scanning to PCI standards. We do collect credit card information, but did not know PCI compliant scans are now required. We use regular Malware Scanning.

Your personal information is contained behind secured networks and is only accessible by a limited number of persons who have special access rights to such systems, and are required to keep the information confidential. In addition, all sensitive/credit information you supply is encrypted via Secure Socket Layer (SSL) technology.

We implement a variety of security measures when a user places an order enters, submits, or accesses their information to maintain the safety of your personal information.

All transactions are processed through a gateway provider and are not stored or processed on our servers. kept for more than 60 days in order

Do we use 'cookies'?

Yes. Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser (if you allow) that enables the site's or service provider's systems to recognize your browser and capture and remember certain information. For instance, we use cookies to help us remember and process the items in your shopping cart.
